SPREAD YOUR WINGS PROGRAM - Spread Your Wings is a scholarship program of up to \$500 per year for foster children to participate in extracurricular activities. We know that when foster children engage in athletic activities, music, dance, or similar activities they develop increased self-confidence and establish meaningful relationships. This program is for children aged 2-18. We provided 228 scholarships totaling \$33,087.97 to foster children throughout Iowa in fiscal year 2025.

SHOE VOUCHER PROGRAM - The Shoe Voucher program is a collaboration between Kiwanis Club of Cedar Rapids, other community organizations and Kohl's. Children in foster care aged 4-18 are eligible to receive up to two pairs of new shoes per year. Caregivers apply online and vouchers are mailed to foster children, so they have the opportunity to shop for and select their own new pair of shoes. We provided 829 pairs of new shoes totaling \$54,761 for foster children throughout Iowa in fiscal year 2025.

SOARING TOWARDS SUCCESS - The Soaring Towards Success program is a tutoring scholarship program to provide up to \$1,000 per year for foster students to access additional academic support. Scholarships also pay for assessments, book, or other applicable educational materials to support foster students academically and get them back on track. We provided 20 scholarships totaling \$3,960 for foster children throughout Iowa in fiscal year 2025.
